MINUTES OF THE MEETING HELD ON 30.01.2024

A review meeting of the Dust Control and Management Cells (DCMCs) of NCR districts of Uttar Pradesh and the major Road construction/maintenance projects in their jurisdiction was held on 30.01.2024 under the Chairmanship of Dr. S. D. Attri, Member Technical, CAQM. A list of participants is at **Annexure**

2. The Chairman welcomed the participants of the meeting and stressed that the dust from roads and open areas is a major contributor to Air pollution. Therefore, all necessary dust control measures must be taken to manage the Air Quality of the region. Thereafter, the status of dust control measures was discussed in detail with the Nodal officers/representatives of the DCMCs present in the meeting.

3. UPPCB made presentation on actions taken to control road dust and also briefed on major construction/ maintenance projects going on in their respective jurisdiction indicating the brief project details, status of completion of project (%), use of anti-smog guns at the project site, status of use of water sprinkling machines, use of dust-suppressants, use of wind breakers, storage and disposal of construction and demolition material and transportation of construction materials during December, 2023. The presentation has been taken on record.

4. Following status of actions/ projects were presented by the DCMCs:

- **Noida Authority** presented the status of under construction projects namely C/o Elevated Road from Agahpur Petrol Pump to NSEZ on DSC road, C/o Golf Course, Sector 151 A and C/o Office Building, Sector-96. It was informed that 36.615 km of open road sides have been paved during December, 2023 and as on 01.01.2024, total length of non-

paved/open roadsides remaining is around 230.49 km. It was informed that 71 anti-smog guns and 62 Water sprinklers (16 Anti Smog Gun & 10 Water sprinklers were added during the month), and 12 MRSM are available and regularly deployed. During December, 543 potholes were filled/repaired.

- **Greater Noida Authority** - It was informed that 72 potholes/ patches were repaired during December, 2023. 78 anti-smog guns and 29 Water sprinklers on tender basis (4 added during the month) and 4 MRSM are available and regularly deployed.
- **NCRTC** presented the status of Delhi-Ghaziabad-Meerut RRTS Corridor of Regional Rapid Transit System in NCR. It was reported that out of the total of 83 Km stretch, 70 km is in Uttar Pradesh and 13km is in Delhi. It was informed, around 16 Anti-smog guns (11 static and 5 truck mounted), 11 Water sprinklers and 5 Road Broomers have been deployed. NCRTC informed that 19.9 km central verges were greened during the month. Also, during December, 2023 14 potholes and 3.5 km road was repaired.
- **Nagar Nigam Ghaziabad**- It was informed that 9 MRSM, 8 anti-smog gun and 31 water Sprinklers are available and regularly deployed. It was intimated that 6.15 km of central verges are yet to be greened, for which action is underway. It was further informed that 250 kg of dust suppressant have been used for road dust suppression in different locations.
- **Ghaziabad Development Authority** presented the status of 9 under construction road projects under their jurisdiction. Major projects include 45m wide road in Rajnagar extension, peripheral road starting from NH-58 till outer ring road, internal roads of PMAY in Raj Nagar etc. It was informed that in all the projects water sprinklers have been deployed and sprinkling is regularly done. 130.93 km of road are under jurisdiction. 3 sweeping machines, 41 Water Sprinklers and 40 anti smog guns (Govt + Private) are available and regularly deployed.

- **Muzaffarnagar Development Authority** It was informed that 36.31 km is under jurisdiction and 1 MRSM, 3 Water Sprinkler and 1 Anti Smog Gun are available with Muzaffarnagar Development Authority.

4. The targets and stipulated timelines as indicated in policy issued by Commission in July, 2022 was also highlighted especially with regard to the Greening of central verges, greening/paving of open road sides and augmentation of MRSM and Water Sprinklers as per requirement. The agencies and UPPCB were advised to comply with the targeted timelines.

5. Following decisions were taken in the meeting:

- i. All the DCMCs should take adequate additional dust control measures and inspections on ground, to ensure proper deployment of the dust control measures including cleaning/sweeping of roads, sprinkling of water on roads etc.
- ii. All the DCMCs must ensure that the road owning/ maintaining and construction agencies undertake all the necessary measures including paving/greening of remaining non-paved roads, filling of potholes, greening of central verges etc. to abate and control dust pollution.
- iii. Adequate nos. of water sprinklers should be deployed.
- iv. All the Nodal officers of DCMCs must attend review meeting & send reports timely.
- v. All the DCMCs to take adequate additional dust control measures and inspections on ground as per GRAP direction to mitigate dust pollution.
- vi. All DCMCs should identify the additional requirement of MRSM, Water Sprinklers, ASGs, paving/ greening of open road sides & Central verges etc. as per CAQM Policy issued in July 2022.
- vii. All DCMCs must ensure the greening of entire central verges under their jurisdiction as per CAQM policy issued in July, 2022. Also, the targets for paving/greening of open road sides must be met and for the remaining stretch of open roadsides, action plan with timelines must be presented in next review meeting.
