The E-Tender processing fee and Earnest Money (EMD) should be deposited only through RTGS and NEFT payment mode from the above link. No other mode payment will be accepeted otherwise tender will be considered as ineligible.
- The tender shall be in two Bid system. Except tender S.No. 1 in case of two Bid system where techno-commercial details such as experience certificates, qualification document etc., Are required then each document must be self-attested with Stamp shall be self verified first. For two bid system the Bidders who do not qualify the pre-qualification requirements shall be summarily rejected and their price Bids would become inaccessible. The price Bid of Bidders who are found eligible in prequalification shall be downloaded through E-Tender procurement system after filling their details on the E-Tender portal.
- B.O.Q. Rates are excluding G.S.T. and G.S.T. will be paid extra as applicable.
