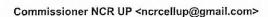

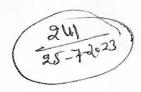

- You are aware that the Geoportal for NCR with name 'PARIMAN' has been launched by Honorable Chairman, NCRPB and Union Cabinet Minister for Housing and Urban Affairs, in the 40th meeting of the Board held on 31,08,2021 and made public on 01,07,2022. The Geo-Portal can be accessed through the NCRPB website https://ncrpb.nic.in/ and also through the web link https://ncrpbgis.nic.in/
